

## **SPHC Player Fee Agreement**

- 1. I understand the tryout fee of \$200 is non-refundable under any circumstances.
- 2. I understand that an additional \$100 tryout fee may be assessed for certain teams, such as birth year teams or the 2008/2007 AA team, as noted during the registration process. The additional \$100 fee is non-refundable.
- 3. I understand that my player is agreeing to commit to the roster spot on the SPHC team that my player is offered for the 2025-26 hockey season and that the commitment fee of \$500 will be applied to my season fee.
- 4. I understand that monthly payments of \$381.67 (\$129.16 for goalies) will be automatically charged, beginning on July 1, 2025, and continuing August 1, 2025, September 1, 2025, October 1, 2025, November 1, 2025, and ending December 1, 2025 for a total of 6 installment payments.
- 5. I understand that I have the option to decline, in writing, the roster position my player is offered within 48 hours of the position offer being posted (offer period). The commitment fee will be refunded if a decline is received, in writing, within 48 hours of position offer posting. Declines received after the 48-hour offer period will result in forfeiture of the \$500 commitment fee.
- 6. I understand that if my player vacates the roster spot on or before June 30, 2025, but after the 48 hour offer period, I will forfeit my commitment fee of \$500, my tryout fee of \$200, and my BY tryout fee, if applicable.
- 7. I understand that if my player vacates the roster spot between and inclusive of July 1, 2025 and September 30, 2025, I will forfeit my tryout fee of \$200 and commitment fee of \$500 and owe the SPHC one-third of the season fee.
- 8. I understand that if my player vacates the roster spot on or after October 1, 2025, I owe the SPHC the entire season fee of \$2990 (\$1475 for goalies).
- 9. I understand the commitment fee will be refunded if my player is not offered a roster position and no season fee charges will occur.

## **SPHC Player Fee Agreement**

Be advised that participation in tryouts with the South Pittsburgh Rebellion does not guarantee placement on any associated team. Team selection is determined by a range of factors, including but not limited to skill level, performance during the tryout process, team requirements, and decisions made by coaching staffs, tryout evaluators, and the board of directors of the South Pittsburgh Rebellion.

While every effort is made to ensure a fair and unbiased evaluation process, and to provide as many placements as possible, it is essential to acknowledge that not all participants may be offered a team placement. The final decisions are made by the aforementioned personnel, and once determined are deemed final; there is no appeal process available for team placement decisions.

In conjunction with the standard fees including the general fee, tryout fee, and commitment fee, players may be required to contribute to a supplementary slush fund. This fund is intended to cover expenses related to tournaments, showcases, and associated team fees, which can vary between \$300 and \$800 depending on the age level and the number of scheduled events.

For teams participating at higher competitive levels and employing paid coaches, an additional coaches fee will be assessed. This fee typically ranges from \$500 to \$800 per player.

These additional fees are essential to sustain the team's operational costs and ensure participation in various competitive events. They are calculated based on the specific needs and commitments associated with each team's competitive program.
