



**SPHC MITE Fee Agreement
2026-2027 Season**

1. I acknowledge and agree that the MITE placement fee of \$200 is refundable only prior to MITE placements, as outlined below.
2. I acknowledge and agree that my MITE registration includes participation in SPHC "Summer Skills and Development" sessions (April–July 2026) and the 2026–2027 Regular Season.
3. I acknowledge and agree that upon registration, my player commits to future placement on an SPHC MITE team for the 2026–2027 season and that the \$465 commitment fee will be applied toward my total season fee.
4. I acknowledge and agree that monthly installment payments of \$147.14 will be automatically charged beginning June 1, 2026, and continuing July 1, August 1, September 1, October 1, November 1, and December 1, 2026, for a total of seven (7) installment payments. Failure to make scheduled payments does not relieve me of my financial obligation under this Agreement.
5. I acknowledge and agree that if my player vacates the roster spot on or before April 1, 2026, I will receive a full refund of the \$465 commitment fee and the \$200 MITE placement fee.
6. I acknowledge and agree that if my player vacates the roster spot between April 2, 2026 and the date of MITE placements, the \$465 commitment fee and any captured monthly installment payments (including June and July payments, if collected) will not be refunded. I will receive a refund only of the \$200 MITE placement fee.
7. I acknowledge and agree that if my player vacates the roster after MITE placements, I will forfeit the \$465 commitment fee, the \$200 MITE placement fee, and any captured monthly installment payments.
8. I acknowledge and agree that if my player vacates the roster spot on or after September 1, 2026, I remain financially responsible for the entire season fee of \$1,695.
9. I acknowledge and agree that I have the option to decline, in writing, the roster placement my player is offered within 24 hours of the placement posting. If a written decline is received within 24 hours, the captured August installment payment (\$147.14) will be refunded. Declines received after the 24-hour period will result in forfeiture of the August installment payment.

10. I acknowledge and agree that financial obligations under this Agreement are not reduced or waived due to injury, illness, playing time, team assignment dissatisfaction, coaching decisions, suspension, voluntary withdrawal, or transfer to another organization.
11. I acknowledge and agree that by registering for MITE participation and/or accepting placement—whether expressly or by failure to decline within 24 hours—I am entering into a binding financial agreement with SPHC for the 2026–2027 season.

SPHC MITE Fee Agreement

In conjunction with the standard fees including the general fee, placement fee, and commitment fee, players may be required to contribute to a supplementary slush fund. This fund is intended to cover expenses related to tournaments, showcases, and associated team fees, which can vary between \$300 and \$800 depending on the age level and the number of scheduled events.

These additional fees are essential to sustain the team's operational costs and ensure participation in various competitive events. They are calculated based on the specific needs and commitments associated with each team's competitive program.
